Standards for Purchasing Environmentally Friendly Products

1. Introduction

The TOTO Group is working to reduce the environmental loads placed on the environment by purchasing low-load, environmentally friendly products (Eco-products, etc.) that are used in our corporate activities. The TOTO Group prioritizes the purchase of environmentally friendly products based on the following criteria.

2. Scope of Application

This set of criteria applies to procurement activities carried out by procurement divisions of the TOTO Group, which will conduct Green Procurement based on the "Evaluation and Selection Criteria" and "Evaluation and Selection of Supplied Goods" specified in the following.

3. Evaluation and Selection Criteria

(1) Evaluation subject

Supplied goods subject to evaluation are components and other goods that constitute the products of the TOTO Group and general goods purchased.

Components and other goods that are a part of products

Products, components, materials, packing materials, and subsidiary materials that accompany products

General goods purchased

Office supplies, toilet paper, work uniforms, office equipment, safety and health products, etc.

(2) Evaluation method

Supplied goods subject to evaluation are evaluated during cost estimation.

If re-evaluation becomes necessary due to changes in evaluation criteria or other reasons, evaluation will be performed as appropriate.

Evaluation items basically include the following, and some supplied goods will be prioritized in purchases based on evaluation of their environmental loads. Other evaluation items may be added in accordance with supplied goods if deemed appropriate.

(3) Evaluation items

The procurement criteria apply to each category of item presented below.

Green Procurement Criteria for General Purchases

1. Procurement Criteria

General purchases give priority to supplied goods that satisfy the following conditions.

- (1) Certified for Eco Mark, Green Mark, or other environmental labels
- (2) Registered in the GPN Database of the Green Purchase Network (GPN)
- (3) Complies with the GPN purchasing guidelines
- (4) Registered as a recommend product of TOTO Purchasing Division
- (5) Specified as an environmentally friendly product based on the company's own standards

Supplied products particularly subject to TOTO's procurement criteria are listed below.

Copier paper, business cards,	Large ratios of waste paper pulp or environmentally friendly
notebooks, product catalogs	virgin pulp are used
Toilet paper	100% recycled paper
Work and office uniforms	Materials contain 50% or more recycled PET resin

Copiers, printers, fax machines,	Conform with International Energy Star Program standards

Office furniture	Designed for easy disassembly after use to facilitate material
